INTRODUCTORY COMMENT

1.-INTRODUCTION

Today the communication techniques have gone improving just as it have develop new communication courses too, now the WAN nets are very important because they reduce bounds and made that the communication be more easy in far away places, allowing increase the capacity and velocity of the communication bits systems.

This manual has general information about WAN nets just as subnetting exercises and this nets configuration.

All the information been in this manual was develop during the 2013-1 period in this sixth semester of the Engineer in Computer systems university course whit the professor support of the Dr. Felipe A. Gonzalez Gonzalez and every his knowledge's contribution.

2.- OBJECTIVES

The principal objectives in this manual is reinforce the basics knowledge's of wide area net just as strengthen the practice of the subnetting exercise and made the configuration process and the carried activities during the semester where the chair has done.

Basic aspects of wide area networks

Wide Area Network

A wide area net or WAN, is a computer network that cover a relative big geographic area. Normally, a WAN covers two or more local area network.

The connected computers to a wide area network normally are connected by publics networks (phone network) the biggest WAN is Internet.

Router

Router is also well known like a packets router. It's a device that brings connectivity for network level or three levels in OIS model. Its principal function consist in send or set data packet of a network to other, means, interconnecting subnets, understanding that subnet is a IP machines group that could communicate without a Router's intervention (by bridges), and as well it has different network prefix.

LAN and WAN differences

LAN:

- *Diffusion Channels
- *Few miles
- *Some Mbps velocity

*One organization

- *Freedom to choice the physic Communication way
- *Reliable channel (mistake rate 1000 less than WAN)
- * Simple Structure for mistake operation

WAN

- *Point by point channels (except satellites)
- *Including whole countries
- *Velocity less than 1Mbps
- *Some organizations
- *Obligation to use public services (for example Telephone network)
- * Unreliable channel
- *Hard structure for mistake operation

<u>CSU/DSU</u>

A CSU/DSU it's a digital interface device, sometimes two far away digital devices that adapt the physic interface of a DTE device (like a terminal) to the DCE advice (like a switch) in a carrying commuted network. Sometimes, CSU/DSU joins to the router.

The way how a connection CSU/DSU advice does is: from the Internet services provider (ISP) TELMEX the signal goes to the CSU/DSU by optic fibre, from there by a Cisco V. 35 cable with DCE-DTE connections made it far to the Router, there it starts to distribute the net.

This is the kind connection that is implemented in the Academic Multidisciplinary Mante Unit and other companies it has been implemented too. This connection could be seen in the 3.2. Illustration

The connection that has been implemented in the Academic Unit is similar to the houses and little offices connections but in this case the signal down from the cloud (Internet Telmex) doesn't arrive to a CSU/DSU advice, but it arrives to a telephone flush which in its turn has connected into a microfilter it's a little advice that reduces the interferences between ADSL signal and telephone signal allowing use telephones, modems, fax, etc. in the same line and plug with the ADLS service. Afterward it connected to a router- modem by a same microfilter port and even a telephone or fax from other port. We can appreciate this connection in 3.3 illustration

DCE/DTE

A serial connection has with data terminal equipment (DTE) at one end of connection and data

communication equipment (DCE) in the other end. The connection between both DCE is the network transmission of the WAN service providers. The signal is receiving in the DCE remote, which decodes the signal again in a data sequences. It sequence is sending, in its turn, to the DTE remote.

There have been developed a lot rules which allow DTE be communicate with DCE. Electric Industrial Association (EIA) and the Telecommunication Standardization Sector of the International Telecommunications Unit (UIT-T) have been active worked developing those standards.

UIT-T refers to DCE as the equipment that finish the data circuit. EIA refers to DCE as the equipment of data communication.



IP Direction

IP direction is a numeric label that identifies logically hierarchically an interface (communication/connection element) of a device (typically a computer) into a network that use a IP (Internet Protocol) corresponding at the OIS Model network.

IP Directions types

There are three IP directions types that an organization could receive from Internet Corporation for Assigned Names and Numbers (ICANN): type "A", type "B" and type "C"

IP consist in 4 octets of 8 bits each one. The value of the first octet is that determines the IP type. The table 3.1 details the proprieties of each type.

Public IP direction

They are visible in the entire Internet. A computer with public IP is accessible (visible)

from any other computer connected to internet. For connect to internet is necessary a public IP direction.

Private IP direction

Private IP directions (reserved) are visible just for other hosts from his own network or from other private networks interconnected by routers. They are used in the companies for the job contents. The computers with private IP directions can access Internet by a router (or proxy) which has a public IP. However, since Internet it doesn't access into a computer with private IP directions. Advantages

- · It's harder identify the user using this IP
- Reduce the operations cost for the Internet services suppliers (IPS)
- For IPS the equipments are more simple

Disadvantages

- Its requires to depend of services rerouted a host into a IP
 - It's unlocatable, in few hours could be some IP changes

STABLE IP DIRECTION

A stable IP direction is an IP which is assigned by the user, as well given by the ISP suppliers in the first connection. The stable IP today in the market of Internet Access have a mensual cost extra. This IP are assigned for the user after to receive the supplier information or as well given by the supplier in the first connection moment. This allow to the user mount web servers, FTP, etc. and lead a domain to this IP without having to keep update the DNS server each time that change the IP like dynamics IP.

Advantages

- · It's easier identify the user that is using this IP
- · Its allow to have services guided directly to the IP
- Never change.

Disadvantages

- · They are more vulnerable to the attach because the user can't get other IP
- · It's more expensive for ISP because these IP couldn't using the 24 hours daily.

NIC

Network Information Center is part of the internet DNS that keep the database of domains names and convert them to IP direction. Each NIC is an organization which controls the name register of the domains into the levels what correspond.

LACNIC

Latin America & Caribbean Network Information Centre

It is the Internet regional register for Latin America and Caribbean. It manages the IP directions version 4 and 6, Numbers of Freestanding Systems, Reverse DSN, and others net

sources for regional network.

LACNIC was established at 2001. Its administrative offices are in Montevideo, Uruguay and the technological complex of the assignment is provided for Management Committee of Brazil (São Paulo Brasil). Before its foundation, the IP services registers for the regional were provided by the American Registry Internet Numbers (ARIN)

Principal WAN Net Activities

- a. Subnetting
- b. Configuration
- c. Administration

Subnetting

Subnetting function is divide a IP network in logical subnets (smaller networks) for each one of them works to sending level and reception of packages as an individual network, even all of them belong to the same physical network and the same domain. The subnetting allows a better administration, traffic control and security to segment the function network.

Subnet Mask

The subnet mask or nets is a data combination that serves for limit the area of a computer network. Its function is indicate to the devices what part of the direction is the number of the network, including the subnet, what part is the host corresponding

MAC direction

In the computers network, the MAC direction (Media Access Control) is an identificator of 48 bits (6 hexadecimal blocks) that corresponds as a unique way for a card or a network device. It has known like physical direction and is once per each device

SOHO Router

The routers are used on private homes and they are known like SOHO (Small Office, Home Office). Those devices allow some equipment have broadband access by a private virtual network and secure.

Network Direction

It's a standard way refers a network. For example, it could does reference to the network in the 10.0.0.0. net. That is more appropriate and descriptive way referring to a network using the word "the first network". Every host of 10.0.0.0 net have the same network bits. Into the IPv4 Direction range of a network the lowest saving for the network direction. This direction has 0 bits for each host in the portion of direction host. Broadcast Direction

The IPv4 broadcast direction is a special direction for each network allowing the

communication in every host in this network. For send data to all hosts in a network it could send just one package to the broadcast direction network. It uses the higher direction in the network broadcast. It is the direction which host proportion bits are all 1. For the 10.0.0.0 network with 24 net bits, the broadcast direction would be 10.0.0.2.55. This direction is known as guided broadcast.

1. Net division in subnets (Subnetting)

4.1 Subnet Concept

On 1985 be defined subnet concept or division of a net number type A,B, C, in more little parts. This concept is introduced for care some problems have started to produced with the directionally classification of the two levels.

The subnets division is a method for manage the IP directions. It consists dividing the complete network directions types in smaller parts. With the subnets division, the network isn't limited to the network mask for type A, B, C and it bring us more flexibity in the network design.

4.2 <u>Net division in subnets importance</u>

The nets could be dividing in smaller subnets this is very important getting more achievement of them also have with this flexibity the subnets division allows the network manager brings broadcast contention and down level security in LAN. The subnets division also brings security because the access to other subnets is available just by a router services.

The IP directions types could take 256 to 16.8 millions of hosts according its type. The subnets creation process started asking "borrow" to the host range the bits necessaries for the subnets required. It should have special care in this action because it should be fewer two bits in the host range. The most bits able to this purpose in type A is 22, type B is 14 and type C is 6.

In the exercise is indicated the amount of bits given with that we'll work for carrying out this exercises will use the resultants values of raising the number 2 to the exponents of O until 16 this is showed in the box 4.1

With the aim of facilitating the next steps and that the division of network is done of easier way, in this method are represented the octets of network (N) as one and the two octets of hosts (H) as zero, how show it now

Once that it converting to binary for class the next step is obtain the number of nets, the formulates to use is $2^{n}-2=2^{3}-2=8-2=6$. The amount on total nets is 8, and the amount of networks usable is 6. These values will be annotating en the box 4.1.1

The next step is to get the value of m, for doing this will count all the zeros of the address in binary by class, except the borrowed zeros.

For getting subnet mask we will add up the value of the bits of each octet, remember that this value go of 1 until 128 from right to left. In the case of a third octet only we'll add up the values of bits that were borrowed.

The sum would stay of the following way:

The first two octets: 128+64+32+16+8+4+2+1=255. Third octet: 128+64+32=224.

For the last one octet, the result will be zero. Then our subnet mask will be the results of the sum of octets values separated for point, in this case will be of the way: 255.255.224.0 And this is our subnet mask.

For getting the bits from subnet mask will sum the amount of one from 2 net octets (N) plus 3 bits of third borrowed octet. The result will be 19 bits.

5.2- exercise: realize subnetting of the address net 179.226.0.0, following the next topology:



This is an exercise of class B.

Let's look the topology that show us that we need 3 nets, then just will use 3 bits borrowed, insomuch that, if we use 2^3 will get 8 less 2 and will be 6 available nets, and this way we will satisfy the nets of the topology.

First step: become form binary to class.

Previously in the exercise 4.1 we look from where to get each one of the variables n,m and f, in this exercise is the same thing $2^{n}-2=2^{3}-2=8-2=6$ Those are the total nets and useable nets $2^{m}-2=2^{13}-2=8192-2=8190$. The internal architecture of a Router Cisco support components that plays an important role in the start up process. The internal components of the router's configuration are :

RAM/DRAM : stores routering tables , the ARP cache of fast switching , the buffering of packages and the queue of packets. The RAM also provide temporal memory and/or work for configuration file router while the router itson . The RAM contents its lose if it produce a switch-off or if the CPU is restarted.

NVARM: The RAM non-volatile stores copy of complete support of the configuration file. The RAM content its preserved during a power outage or electrical, the CPU is restarted.

FLASH: ROM erasable, reprogrammable that retains the image and the microcode for the operative system. The flash enable updates of software without removing and replacing the processor chips. The flash content its conserve during switch-off or reboot. Flash memory can store multiples versions of Software.

ROM: Contains power-up diagnostics about steps program and Software Operating System. The updates require removal and replacement of pluggable chips on the CPU.

INTERFACES: Network connections on the motherboard or on separate interface modules across the renaming of the which packages entering and leaving a router.

Steps to turn on a Router.

After the power on selftest of the router, occur the following events as they initial the router.

Step 1.- The generic bootstrap loader ,which is located in the room , executes on the CPU card . A bootstrap is a simple operation by default to load instructions which in turn cause other instructions to be loaded into memory, or cause entry to other modes of configuration.

Step 2.- The operating system (Cisco IOS) can be found in one of several places. It reveals the location in the field to start the configuration record. If the boot field indicates a flash or network load, boot system commands in the configuration file indicate the exact location of the image.

Step 3.- The operating system image is loaded . When it's loaded and running, the operating system locates the Hardware and Software components and displays the result on the console terminal.

Step 4.- The saved con figuration files in NVRAM is loaded into main memory and executes line by line. These configuration commands start routing processes, provide addresses for interfaces establishing the characteristics in the media, etc.

Step 5 .- If there is not valid configuration in NVRAM, the operating system executes a configuration routine with initial questions called system configuration dialog, as known as initial configuration dialog.

6.3 The IOS Cisco

Cisco IOS (originally internet work Operating System) is the software used in the vast majority of routers and switches-off. IOS is a package of routing functions, commutation, Ethernet work and telecommunications that is tigthy integrated with a multitasking operating system.

The command –line interface or IOS (IOS CLI) provides a fixed set of commands for multiples words. The package available is determinated by the "mode "and level of privileges of the current user. The "Global configuration" mode provides commands to change the system configuration and the interface configuration mode to turn provides command to change the settings for a specific interface. To all of the commands are assigned a privilege level of 0 to 15 and can be accessed by users with the necessary privileges. Through the CLI, you can define the available commands for each level of privilege.

6.4 PROTOCOLS

6.4.1 Router Protocols

A routed protocol allows the router will send data notes between different Networks. Is a Protocol of level 3 decking to transfer information from one device to another in the form of a network. Routing protocol is the datagram of level 3 that takes information from the application in addition to information on the higher levels.

Features: A router protocol allows the router will send data between nodes of different networks. For a protocol to be routable, must support the ability to assign to each individual device a number of network and one of the hosts.

Routing Protocol is the implementation of a routing algorithm in the software or hardware. A routing protocol an algorithm the application of routing in the software or hardware.

Advantages:

- Is easier to configure (comparatively to others products).
- It's an open protocol (supports derived versions although not necessary compatible).
- It's supported by most of manufacturers.

Disadvantages:

Its main disadvantage is that, in order to determinate the best metric, only takes into account the number of hops, downloading other ______. It's not designed to solve any problem of routing. The RFC 1720 (STD 1) describes these technical limitations of RIP serious and the IETF is evaluating candidates to replace it, within which OSPF is the favorite. This change is hampered by the wide expansion of RIP and need appropriate arrangements.

6.4.2 Routing protocols

Routing protocols are the set of rules used by a router when it communicates with other routers to share routing information. This information is used to build and maintain the routing tables.

Features:

Routers must maintain routing tables and ensure that others routers know of changes in the topology of the network. This function is carried out using a routine protocol to communicate the information of the network to other routers. When the package arrives at an interface, the router must use the routing table to set the destination. The routers send the packets to the appropriate interface, add information necessary framing for that interface, and then transmits the frame.

Advantages:

Only changes in the state of the link are sent. Which significantly reduces the bandwidth required. Although the changes are sent to all routers associated with the interconnection simultaneously, the convergence time is reduced. Significantly provide control and flexibility for routing

information cross the renaming of the interconnection.

Disadvantages:

Increases the complexity of the installation, increases the internal processing requirements (memory of the CPU). The routing protocols can be classified into two types, distance vector and link state.

Distance vector:

The vector distance means that the routers are published as vector of distance and direction. This distance is defined in terms of metric like the hop count and the address is simply the next – hop router or the output interface. The distance vector protocols generally use the Bellman Ford algorithm for the determination of the best path.

Link status:

Unlike the operation of the protocol of the distance-vector routing, a router configured with a linkstate routing protocol can fall a full view or Topology of the network to gather information from all other routers. To continue, the use of a routing protocol Link state is like having a complete map of the network topology. The signs along the route from source to destination are not necessary, because all the routers on the link state use a map to the same network.

A router uses the link state information of link state to create a map of the Topology and select the best route to all the destination networks in the Topology.

Some of the most common protocols for routing include RIP, IGRP, EIGRP, OSPF, IS-IS and BGP. Bellow will explain two of them: RIP and EIGRP

RIP Protocol

RIP (Routing Information Protocol) is one of the routing protocols used by older IP based devices. It's originally implementation was for the XEROX pup protocol at the beginning of the 80's, won popularity when was distributed as the routing protocol. For the implementation TCP/IP. RIP is a distance vector protocol that uses the account of routers hops as metric. The account of hops maximum of RIP is 15. Any path that exceeds 15 hops is labeled as unreachable with the establishment of the account of jumps in 16.In RIP routing information is propagated from one router to the other neighbors by means of dissemination of IP using the protocol UDP and port 520.

The rip protocol version 1 is class routing protocol that does not support the publication of information of the net mask. The RIP protocol is a protocol without class that supports CIDR and VLSM, summary of routes and security through simple text and md5 authentication.

It's should be noted:

- RIP is a routing protocol based on distance vector. The RIP uses the number of metric data as to the selection of routes.
- The RIP routing updates disseminated by means of the ro
- The maximum numbers of hops allowed in RIP is 15.
- The RIP routing updates disseminated by means of the routing table complete every 30 seconds by default.
- RIP may perform balance of download to a maximum of six equal cost routes (the specification by omission of four routes).
- RIP requires that you use a single network mask for each network number of main class that is announced. The mask is a subnet mask of fixed length. The standard rip-1 does not contemplates triggered updates .
- RIP 2 allow subnet masks variable length (VLSM) in the interconnection. (The standard rip 2 allow triggered updates unlike the rip-1 the definition of the maximum number of parallel paths allowed in the routing table empowers RIP to carry out the load balancing.

EIGRP Protocol

EIGRP protocol (Enhanced Interior Gateway routing protocol). Is a routing protocol vector of distances and a routing protocol of link state, owned by Cisco Systems, which offers the best of the vector algorithms of distances and the condition link. It's considered an advantaged protocol that is bases on the characteristics normally associated with the protocols of the state link. Some of the best features of OSPF as a partial updates and the detention of neighbors, are used in a similar

manner with EIGRP. But does not guarantee the use of the best route, is quite used because EIGR is somewhat easier than configure that OSPF. EIGRP improves the convergence properties and operates more efficiently than IGRP. This allows a network has enhanced architecture and be able to maintain the current investments.

The most relevant features of EIGRP are:

- 1.- Reliable transport protocol (RTP)
- 2.- Updates limited
- 3.- Algorithms of updates by diffusion (DUAL)
- 4.- Establishments by adjacencies .
- 5.- Tables of neighbors and topology.

Routers EIGRP maintain routing information and at disposal of the RAM, so they can react quickly to changes. Like that OSPF, EIGRP saves this information in multiple tables and databases, routes are given a state and can be tagged to provide additional useful information.

EIGRP maintain the following three tables :

Neighbors table: Each router EIGRP maintains a table of neighbors that lists adjacent routers. This table can be compared with databases used by OSPF adjacency. There is a table of neighbors for each protocol that supports EIGRP.

Topology tables: The table of topology consists of all the routing tables EIGRP received from neighbors. EIGRP takes the information provided in the neighbor table.

Network Specific the networks directly connected to the router that will be announced by RIP. **Version** adopts a value of 1 or 2 to specify RIP's version that is going to be in use. If the version is not specified, the software IOS adopts as predetermined option the sending of RIP version 1 but it receives updates of both versions, 1 and 2.

(Optional) Maximum-paths enables balanced of load.

Protocolo EIGRP

EIGRP (Enhanced Interior Gateway Routing Protocol)

It is a protocol of routing vector distance and a protocol of routing of link-state, property of Cisco Systems, which offers the better of the algorithms of vector of distances and of the condition of link. It is considered to be an advanced protocol that is based on the characteristics normally associated with the protocols of the condition of link. Some of the OSPF's best functions, as the partial updates and the neighbors' detection, are used in a similar form by EIGRP. Though it does not guarantee the use of the best route, it is used widely because EIGRP is slightly easier to configure that OSPF. EIGRP improves the properties of convergence and produces with major efficiency that IGRP. This allows that a network should have an improved architecture and could support the current investments in IGRP.

1- Reliable Transport Protocol (RTP), 2-Limited Updates, 3- algorithm of update for diffusion (DUAL) 4-Establishment for adjacencies 5-neighbors' Tables and topología. The routers EIGRP support information of route and topology.

The routers EIGRP support information of route and topology to disposition in the RAM, in order that they could react rapidly to the changes. As OSPF, EIGRP guards this information in several tables and databases.

The routes receive an state and can be labelled to provide additional information of usefulness. EIGRP supports the following three tables:

• Neighbors' table

Every router EIGRP supports a neighbors' table that enumerates the adjacent routers. This table can be compared with the database of adjacency used by OSPF. A neighbors' table exists for every protocol that EIGRP admits.

• Table of topology

The table of topology consists of all the tables of routing EIGRP received from the neighbors. EIGRP takes the information provided in the neighbors' table and the table of topology and calculates the routes of minor cost towards every destination. EIGRP traces this information in order that the routers EIGRP could identify and commute to alternative routes rapidly. The information that the router receives from the neighbors is used to determine the route of the successor, who is the term used to identify the principal route or the best. This information also interferes to the table of topology. The routers EIGRP support a table of topology for every protocol configured in the network (as IP, IPv6 or IPX). The table of enrutamiento supports the routes that are learned in a dynamic way.

Table of routing

The table of routing EIGRP contains the best routes towards a destination. This information is recovered from the table of topology. The routers EIGRP support a table of routing for every network protocol.

routereigrp 240 It specifies EIGRP as protocol of routing for the system

Bandwidth. The process of routing uses the command bandwidth to calculate the metrics and

it is suitable to configure the command in order that it coincides with the speed of the interface.

log-neighbor-changes enables the record of the changes of neighbors' adjacency to monitor the stability of the routing system and to help to detect problems.

In IOS's current versions EIGRP adds to the network command the correspondent wilcard this allows the protocol the identification of subnetworks:

router(config)#router eigrp 240

router(config-router)#network 192.168.16.0 0.0.0.255

The metrics

The metrics is a value used by the routing protocols to assign costs in order to reach any remote network, every protocol uses his own metrics, for example RIP uses the jumps counting, EIGRP that is a property of cisco uses a combination of bandwidth and delay, On the other hand OSPF uses the bandwidth. The jump count that RIP uses is the simplest metrics to understand, which means, the jump count refers to the quantity of routers that it must cross a packet to reach the network of destination. The metrics enters function when the router learns more than one route towards the same destination, for such the protocol of routing must evaluate and differentiate between the available routes and to select the route with the lowest metrics. many attributes to measure the routes.

Split Horizon

What is and what is the function of Split Horizon?

A Split horizon (divided horizon) takes place when a router tries to send information about a route again in the direction from where it came. For example: The Router 1 initially public that has a route towards the Network A. As result, there is no motive for the Router 2 to not include this route of return towards the Router 1 because the Router 1 is the nearest to the Network A The norm of

Split horizon establishes that the Router 2 must eliminate this route of anyone of the updates that it sends to the Router 1.

The norm of Split horizon helps to prevent the loops of routing. For example, let's suppose that the interface of the Router 1 towards the Network A stops working. Without the Split horizons, the Router 2 continues informing the Router 1 that can come to the Network A (across the Router 1). If the Router 1 is not sufficiently intelligent, it can end selecting the route of the Router 2 as an alternative for the direct connection that has failed, provoking a loop of routing. Though the waits should anticipate this, the Split horizons are implemented in IGRP as a way of supplying additional stability of protocol.

- RIP
- IGRP
- EIGRP
- VPLS They use the technology of divided horizon to avoid the cycles in the plan of reare disp.

6.5 Basic configuration of a Cisco router

6.5.1 change the name of the router

The name of the router can be modified in order to be able to differentiate it in the network or networks. The command will be executed in way of global configuration.

Router(config)#hostname<Name>

A different name will appear in the prompt in meetings HyperTerminal or Telnet.

6.5.2 Configuration of the Ethernet interfaces of the Router

Now, we must do that they communicate both networks connected to the Router. Let's suppose

that the name of the interface connected to a computer is Fast Ethernet 0/0 and that of the one

connected to the computer 2 is Fast Ethernet 0/1, being in global configuration mode. Here the commands to input:

• Interface fastEthernet 0/0:

Router (config) # interface fastEthernet 0/0 Router (config-if) # ip address 192.168.1.1255.255.255.0 Router (config-if) # no shutdown Router (config-if) # exit

Interface fastEthernet 0/1:

This is all in relation to the configuration of the interfaces. Both networks should communicate now between them. We can verify it with a ping command of a PC of a network towards a PC of another network.

To save the current configuration we will use the command write from the privileged mode.

If the interface that is going to be configured is serial, the procedure that follows is the same, but only the command clockrate will be added with the speed of synchronization for example 64000.

6.5.3 Configuration of passwords in the Router Cisco

Turning on the router Password

The first thing that it is necessary to do is to connect in privileged mode, then in the mode of global configuration to effect this manipulation: Router > enable Router # configure terminal Router (config) #

Once in global configuration mode, it is necessary to enter the mode of configuration of line typing on the following Router(config)#line console 0

In the mode of configuration of line we type the wished password followed by the command login. Router(config-line)#password <contraseña> Router(config-line)#login

we can now leave the configuration of line mode with the command exit, later we do the same thing to go out of the global mode, and already being in privileged mode we save the configuration with the command write.

Router(config-line)#exit Router(config)#exit Router#write Router#exit Router>

Password to the Privileged access

This part explains how to put a password to the privileged user.

The first thing that it is necessary to do is to connect in privileged mode, then in mode of global configuration to effect this manipulation:

Router > enable Router # configure terminal Router (config) #

Once in mode of global configuration, it is necessary to type a command to put a password: Router (config) * enable password password>

The next time that a user tries to connect in privileged user mode, will be requested him a password.

Configuration of the Telnet Access to Router.

Since the configuration with the cable of console and HyperTerminal is not practical, it is possible to allow that the administrators should connect to the router via a Telnet session from any PC of one of both networks.

We start in mode of global configuration, then in mode of configuration of line VTY:

Router > enable Password?: Router # configure terminal Router (config) # line vty 04

This will configure the possibility of 5 telnet sesions simultaneously in this router. We come now to the prompt of configuration of line. To activate Telnet, we have to put a password to the line:

Router (config-line) # password contraseña Router (config-line) # exit

We save the configuration with the command write.

6.5.4 Commands of information in Cisco Routers

The commands of information allow to show the information relative to the router. They all begin with the prefix show or sh. The majority must be executed from the privileged mode. Show the file of current configuration of the router:

1. PACKET TRACER[®] CISCO

After realizing the exercises of division of networks, some of them were practised in the software PacketTracer from Cisco, in which simulations can be carried out by the devices of network as if one was working physically in real life.

7.1 What is Packet Tracer?

Cisco Packet Tracer is a software property of Cisco System, Inc., designed for the simulation of networks based on the equipments of the mentioned company. Together with the didactic materials designed for such, it is the principal tool of work for tests and simulation of practices in the training courses of Cisco System. For his utilization there is needed the acceptance of the user's license and the authorization of the owner across the entities named "academies" that are authorized for the imparting of the mentioned courses.

7.2 The work environment of Packet Tracer

In Packet Tracer's working space they find different zones:

 \cdot Zone of menus. It is the area where they find the typical options of all the programs for the management and the configuration of the software.

· Selector of presentation. It allows to change between logical scheme and physical scheme at the moment of presenting the devices. The habitual thing is to work with the logical scheme.

• Working space. It is the zone where there will place the devices that shape the network

 \cdot Toolbar. It provides tools to select devices, to move the working space, to analyze specific parameters of the devices (the magnifying glass), to generate units of information of protocol simple or complex.

• Selector of operation modes. To change between the way of Real time or the Simulation mode, which allows us a more detailed analysis of all the PDU of the different protocols that intervene in a communication in the network.

• Selector of scenarios. It serves to effectuate different analyses on the same network. • Area of state of the scenario. It shows the UDP that have intervened in the effectuated analysis, be real time or in simulation mode, for each of the scenarios or situations in that it has been operated the network.

• Area of devices. It is the zone that allows to select the devices that are going to be included in the working space, as well as the connection between these. The left zone gathers the devices for groups and the right zone of the area offers the included devices, in agreement with the numeration used by Cisco System.

In the illustration 7.2.1 we observe the environment of work of the Packet Tracer.

7.1 How to create a topology in the Packet Tracer

The way of operating of Packet Tracer is very simple since it is very intuitive program. The first operation will consist of selecting the devices that form the network, for it the corresponding group will be selected: from left to right and from up to down: Routers, Switches, Hubs, wireless Devices, Connections, final Devices, WAN's Emulation, personalized Devices and multiuser connection. In the illustration 7.3.1 we can observe the available routers in the Packet Tracer.

Each of the eligible devices corresponds with a device made by Cisco System, except the so called Generic devices. The eleccion of the devices can be done one to one (indicating it in the group and doing click in the scenario to place it) or if it's about several similar devices, indicating in the group simultaneously pressing the Ctrl key.

The connection of the different equipments can be realized choosing personally the type of connection or by means of the tool of connection to automatic way. In any case, it is necessary to indicate on the devices to connection, if the case needs it, we will be given the possibility of choosing the type of interface.

8. CONCLUSIONS

8. During the period the lesson of wide area networks took place we were able to obtain many knowledge, between them to know wherefrom there come the IP addresses that have the networks, this is done when "subneting", another of the knowledge that were acquired it is to know how a WAN network is composed, the devices that are involved, etc., also we learned to configure the Routers and to connect them in order that they could configure the WAN network, all that with the aim to achieve that the communication is done from a place to another by means of the use of these devices of network and to achieve thus an ideal configuration.
